**OIL PIPELINE TARIFF FILING**

Dear Secretary Reese:

In accordance with the requirements of the Interstate Commerce Act (“ICA”) and the Rules and Regulations of the Federal Energy Regulatory Commission (“Commission”), in particular Section 341.3 (Form of Tariff) and 342.3 (Indexing), 18 C.F.R. §§ 341.3, 342.3 (2025), Hiland Crude, LLC, d.b.a. Hiland Express Pipeline (“Hiland Express”) submits for filing the following tariffs, effective July 1, 2026:

- FERC No. 2.1.0, Local Rates Tariff (cancels FERC No. 2.0.0)
- FERC No. 3.1.0, Volume Incentive Rate Tariff (cancels FERC No. 3.0.0)

FERC Tariff No. 2.1.0 has been adjusted in accordance with the applicable ceiling level. Included in this filing is a table showing the Tariff Schedule Changes, which contains the information required by 18 C.F.R. § 342.3(b), including the rate schedule to be changed, the proposed new rate, the prior rate, the prior ceiling level, and the applicable ceiling level effective July 1, 2026. The local rates in FERC Tariff No. 2.1.0 are proposed in accordance with Section 342.3(a) of the Commission’s regulations, which permits a carrier to change a rate to a level which does not exceed the then-applicable ceiling level.<sup>1</sup>

FERC Tariff No. 3.1.0 has been adjusted in accordance with the applicable ceiling level. The rates to be indexed in FERC Tariff No. 3.1.0 are proposed in accordance with Section 342.3(a) of the Commission’s regulations, which permits a carrier to change a rate to a level which does not exceed the then-applicable ceiling level.<sup>1</sup>
