Dear Acting Secretary Reese:

In accordance with the requirements of the Interstate Commerce Act (ICA) and the Rules and Regulations of the Federal Energy Regulatory Commission ("FERC" or "Commission"), Kinder Morgan Utopia LLC ("Utopia") submits for filing the following tariff ("International Joint Volume Incentive Rate Tariff"), effective October 1, 2024:

- FERC Tariff No. 3.8.0, International Joint Volume Incentive Rate Tariff applying on the transportation of purity ethane (cancels FERC Tariff No. 3.7.0)
- FERC Tariff No. 7.5.0, International Joint Volume Incentive Rate Tariff applying on the transportation of purity ethane (cancels FERC Tariff No. 7.4.0)

I. Explanation of Tariff Filing

Utopia is filing the International Joint Volume Incentive Rate Tariff in compliance with 18 C.F.R. § 342.3 (2024) ("Indexing") and the FERC's Order Reinstating Index Level¹ to increase certain of the rates for services outlined in the International Joint Volume Incentive Rate Tariff, with such increases to become effective October 1, 2024. Pursuant to 18 C.F.R. § 342.3, Utopia is enclosing herewith an Index Summary that outlines, with respect to the rates in the International Joint Volume Incentive Rate Tariff, the following information: (1) the current rates, (2) the index ceiling levels that are now effective pursuant to the Order Reinstating Index Level,² and (3) the rates that will become effective on October 1, 2024.

Utopia's International Joint Volume Incentive Rate Tariffs have been adjusted in accordance with the applicable ceiling level. As shown in the Joint Rate Justification Table included in this filing, the sum of the local rate in FERC Tariff No. 2.5.0 and Kinder Morgan Utopia Ltd. local rate in CER No. 25, is less than or equal to the International Joint Volume Incentive Rates.

I. Request for Special Permission to File on Short Notice

In accordance with the Order Reinstating Index Level,³ Utopia requests special permission to issue the International Joint Volume Incentive Rate Tariff on less than 30 days' notice under authority of 18 C.F.R. § 341.14 and § 341.2, so that the adjusted rates reflected therein go into effect on October 1, 2024. Utopia submits that good cause exists for granting this request, since the Commission expressly indicated in the Order Reinstating Index Level that oil
